

**REQUEST FOR PRESERVATION OF BODY WORN CAMERA, IN CAR VIDEO, OR ANY
OTHER KNOWN ORIGINAL VIDEO DATA**

I UNDERSTAND THERE IS BODY WORN CAMERA (BWC) VIDEO, OR IN CAR VIDEO DATA RELATED TO THE CRITICAL INCIDENT I WAS INVOLVED IN ON _____.

THIS DIGITAL VIDEO DATA IS CONTAINED ON THE CAMERA ISSUED TO ME BY MY DEPARTMENT, AND ON OTHER BODY WORN CAMERAS/IN CAR VIDEO CAMERAS RELATED TO THIS INCIDENT. VIDEO DATA IN ITS ORIGINAL FORM IS NECESSARY FOR AN ACCURATE ANALYSIS OF THE VIDEO ITSELF, I.E., IMAGE RATE, MACRO-BLOCK ANALYSIS, AND OTHER TECHNICAL DATA. THE ORIGINAL VIDEO IS NECESSARY EVIDENCE FOR USE IN THE MOST ACCURATE ANALYSIS POSSIBLE OF THIS INCIDENT. ORIGINAL VIDEO INFORMATION, WHEN IMPROPERLY DUPLICATED, MAY BE TRANSCODED INTO TO A DIFFERENT FORMAT, AND MAY ALTER THE COMPOSITION OF THE VIDEO, THUS STRIPING THE CRUCIAL VIDEO META DATA CONTAINED IN THE ORIGINAL VIDEO. THIS WILL PREVENT THE MOST ACCURATE ANALYSIS POSSIBLE OF THE VIDEO DATA RELATED TO THE INFORMATION CAPTURED ON SUCH CAMERAS. THE UNDERSIGNED AND MY ATTORNEY ARE REQUESTING THAT ALL BODY VIDEO CAMERAS/IN CAR VIDEO CAMERAS OF ANY OFFICER INVOLVED IN THE INCIDENT, OR WHOSE VIDEO CAMERAS MAY HAVE CAPTURED THE INCIDENT, BE TAKEN INTO EVIDENCE AND PRESERVED FOR THE REASONS OUTLINED ABOVE. ALTERNATIVELY, I REQUEST THAT THE HARD DRIVES ON SUCH CAMERAS BE TAKEN INTO EVIDENCE AND PRESERVED. THIS REQUEST ALSO INCLUDES THAT NO IMPROPER REPLICATING OR HANDLING OF THE VIDEO EVIDENCE TAKES PLACE, AND THAT ALL PROCESSES ARE ACCURATELY DOCUMENTED FOR FUTURE EXAMINATION, TO PRESERVE THE INTEGRITY OF THE EVIDENCE AND THE INVESTIGATION FOR ALL INVOLVED PARTIES.
